Dr. Victoria L. Bastecki-Perez, President, Montgomery County Community College

Dr. Victoria L. Bastecki-Perez became the sixth President of Montgomery County Community College in May 2020. As the leader of the institution, Dr. Bastecki-Perez relies on her decades-long career in academia to guide every aspect of student life, faculty involvement, community engagement, administrative efforts, and academic excellence that take place at the College and in the surrounding communities every day.

For nearly 25 years, Dr. Bastecki-Perez has dedicated herself to serving Montgomery County Community College. Today, she is focused on further solidifying the College's status as a premier community college by elevating all aspects of the student experience, increasing access and retention initiatives, and providing students with the tools, guidance, and resources they need to thrive in pursuit of their academic goals. She has a clear strategic vision for how to lead the College, an uncanny ability to unify the campus community, and a keen eye for improving the financial stability and sustainability of the organization.

Dr. Bastecki-Perez is a first-generation college graduate in her family. This experience has taught her the transformative impact a quality education can have on an individual's life and has greatly influenced her academic and leadership journey. Dr. Bastecki-Perez has since committed herself to expand academic equity and inclusiveness in the name of providing others with a similar life-altering opportunity.

As president, she is focused on elevating student success and equity. In her prior roles as Vice President of Academic Affairs and Provost, she worked diligently to enhance the academic enterprise through the creation of a five-year strategic plan for academic program development and delivery, including associate degrees, industry credentials, and certificates of completion that meet student transfer and employability needs.

As Chief Academic Officer, she broadened the Faculty Diversity Fellows Program to increase the number of fellows and to incorporate librarian and advisor roles in an effort to make the College's faculty even more reflective of the school's diverse student body. In doing so, she enriched the community with the energy and creativity that comes with diverse perspectives. This work also led to the College's recognition as one of the Most Promising Places to Work in Community Colleges for five consecutive years, a distinction that salutes community colleges that cultivate diverse, inclusive and supportive workplaces and learning environments.

Under Dr. Bastecki-Perez's leadership, the College also has earned the prestigious Achieving the Dream's Leader College of Distinction designation for its collective efforts in improving student outcomes and narrowing equity gaps. As part of the Middle States Commission on Higher Education (MSCHE), a non-governmental membership organization to promote educational excellence, she proudly participates as an Accreditation Liaison Officer to uphold high standards across accredited colleges.

Her close work with the Montco Family spans nearly 25 years, having served in three other capacities at the College in the roles of Associate Vice President of Academic Affairs (2006-2010), Dean of Health and Physical Education (2000-2006), and Director and Professor of Dental Hygiene (1996-2003) at the College. Before joining Montgomery County Community College, she was an award-winning faculty member and Senior Clinical Supervisor at the University of Pittsburgh, School of Dental Medicine for nine years.

Dr. Bastecki-Perez's accomplishments extend far beyond the College's campuses as a pillar of the broader Montgomery County and Pennsylvania academic community. She values the partnerships forged within Montgomery County to address broader educational needs and support services for residents and student. Currently, she serves as a member of the Pennsylvania Commission for Community Colleges Council of Presidents, the T.E.A.C.H. Early

Childhood® PENNSYLVANIA Advisory Committee, as well as the Pennsylvania Higher Education Assessment Leaders council. Additionally, Dr. Bastecki-Perez serves on the boards of directors of MontcoWorks (formerly Montgomery County Workforce Investment Board) and the Collegiate Consortium for Workforce & Economic Development.

As an accomplished scholar, Dr. Bastecki- Perez completed the entirety of her own education within the commonwealth. She holds a CDA (1985) and RDH (1986) from the University of Pittsburgh, Dental Assisting and Oral Hygiene, and a B.S. (1987) in Education from Edinboro University of Pennsylvania. She began her graduate coursework in 1988 at Exeter College, Oxford University through the Edinboro-Oxford Experience study abroad program, before going on to earn an Ed.D. (1995) and M.Ed. (1990) in Instructional Design and Technology from the University of Pittsburgh. She was recognized as a Distinguished Alumna by Edinboro University in 2000 and by the University of Pittsburgh in 2010. Her insights and studies have been cited and published in a wide-array of professional journals, and she has conducted countless presentations throughout her career to the academic and scholarly communities on local and national stage. This educational journey has uniquely influenced and positioned Dr. Bastecki-Perez for the leadership role she holds today guiding the students and faculty of the College to successful academic outcomes.

Dr. Bastecki-Perez considers herself a life-long Pennsylvanian, and has resided in Montgomery County for nearly 20 years with her husband and daughter. In her spare time, Dr. Bastecki-Perez enjoys spending time with her extended family, including her two stepdaughters, traveling, swimming, and dancing with her husband.

Tim Carty, Co-Founder & Chief Strategy Officer, RoleCall

Tim Carty began his career in sales and marketing before discovering a passion for community advocacy and economic development. Combining his experience in inbound marketing with his work as director of talent attraction for the Iowa City/Cedar Rapids area, Tim developed an innovative talent attraction strategy that drew national attention. He also developed and ran Wingman, a community onboarding program that has been duplicated successfully around the country. As RoleCall's chief strategy officer, Tim helps communities operationalize their talent attraction strategies, creating systems to capture and nurture leads and connect them with local employers. Tim was named one of DCI's top 40 Under 40 Economic Developers for 2021.

Dr. Silas Chamberlin, VP, Economic & Community Development, York County Economic Alliance

Silas Chamberlin, PhD, is vice president of economic development at the York County Economic Alliance, a position in which he serves as executive director of both the Redevelopment Authority of the County of York and the York Business Improvement District Authority and oversees a variety of economic financing, business attraction, and workforce development initiatives throughout York County. Silas's team is leading creation of the Bloom Empowerment Center and Bloom CDFI to expand access to capital and technical assistance for minority- and women-owned businesses in York County.

Silas previously served as CEO of Downtown Inc, executive director of the Schuylkill River National Heritage Area, and in regional leadership roles with the PA Department of Conservation & Natural Resources and the Delaware & Lehigh National Heritage Corridor. Silas holds a PhD in environmental history from Lehigh University and a certificate in commercial real estate development from Cornell University. He is an adjunct professor of urban revitalization at York College. Silas is immediate past chair of the Pennsylvania Humanities Council board of directors, a board member of the Pennsylvania Downtown Center, and currently serves as a Governor's appointee to Pennsylvania's Conservation & Natural Resource Advisory Council.

David L. Cohen, Senior Advisor, Comcast Corporation

David L. Cohen - is Senior Advisor to the CEO at Comcast Corporation. Effective January 1, 2020, David has announced a transition from his leadership role as Senior Executive Vice President where he led a broad portfolio of responsibilities that he helped to create and oversee since his arrival at the Company, including corporate communications, legal affairs, government and regulatory affairs, public affairs, corporate administration, corporate real estate and security, and community impact. David also served as the company's first Chief Diversity Officer. Before coming to Comcast in July of 2002, Mr. Cohen served as a partner in and Chairman of Ballard Spahr Andrews & Ingersoll, LLP, one of the 100 largest law firms in the country.

A native of New York, Mr. Cohen graduated from Swarthmore College in 1977 with a BA and with a JD from the University of Pennsylvania Law School summa cum laude in 1981. From January 1992 to April 1997, Mr. Cohen served as Chief of Staff to the Honorable Edward G. Rendell, the Mayor of the City of Philadelphia. As detailed in the book *A Prayer for the City*, written by Pulitzer-Prize winning author Buzz Bissinger, Mr. Cohen played a critical coordinating role in significant budgetary and financial issues, in economic development activities, in collective bargaining negotiations, and in a wide variety of other policy and operational issues relating to the city.

David serves as Chairman of the Trustees of the University of Pennsylvania and its Executive Committee. He also serves as a member of the Trustee Board and the Executive Committee of Penn Medicine. In addition, David serves on both the Board of Directors and the Executive Committee of the Greater Philadelphia Chamber of Commerce, and is a member of the Chamber's CEO Council for Growth. He is also Chair of the Philadelphia Theatre Company, is a member of the United States Semiquincentennial Commission and a member of its Executive Committee, Honorary Chair of Campus Philly, a member of the Kimmel Center President's Leadership Council, and is Chair of the 2026 FIFA World Cup Philadelphia Bid Committee. David also serves as Chair of the national board of City Year and its Executive Committee and Co-Chair of its Governance Committee. He also serves on the national board of the National Urban League and is Chair of its Audit Committee, and is Chair of the Corporate Advisory Board of UnidosUS. David is a member of the Board of Directors of FS Global Credit Opportunities Fund and serves as Chair of its Nominating and Corporate Governance Committee. Additionally, David serves on the Board of Directors of the PNC Financial Services Group, Inc. and PNC Bank, National Association, and is a member of the Audit Committee, the Personnel and Compensation Committee, and the Special Committee on Equity and Inclusion.

Mr. Cohen has received numerous awards for his civic and charitable activities, including the Americanism Award of the Anti-Defamation League (1993), the American Red Cross Citizen of the Year Award (1999), the National Cable Television Association, Vanguard Award for Leadership and Impact in the Cable Industry (2005), the President's Volunteer Service Award (2007), the MS Society Hope Award (2007), the Drexel University Business Leader of the Year Award (2008), the National Urban League of Philadelphia Business Leader of the Year Award (2008), The William Way Community Center Amicus in Res Award (2009), the William Penn Award from the Greater Philadelphia Chamber of Commerce (2012), Spirit of Asian American Award (2012), the Jewish National Fund Tree of Life Award (2012), the Minority Media Telecommunications Council Digital Equality Award (2013), and the Minority Corporate Counsel Lifetime Achievement Award (2017); the 4-H Brand Champion Award (2018), Kappa Alpha Psi's "Distinguished Citizens Award" (2019), the American Horizon Award from the Media Institute (2020), and the President's Award from the National Urban League (2020), and has consistently been named to Black Enterprise magazine's list of top corporate diversity executives. Mr. Cohen also was awarded an Honorary Doctor of Laws degree from Drexel University in 1997; an Honorary Doctor of Laws degree from Rider University in 2010; an Honorary Doctor of Laws degree from Rowan University in 2017, and Honorary Doctor of Laws Degree from Rohrer College of Business in 2019.

SEF finances a variety of energy efficiency and renewable energy projects through commercial loans, energy savings agreements, and power purchase agreement, as well as administering C-PACE programs throughout Pennsylvania. Prior to joining SEF, Mr. Costlow served in management capacities throughout the energy industry including Manager of Marketing and Energy Conservation for Florida Public Utilities and Vice President of Energy Control Companies. Pre-Conference Session - Navigating Business Structures & Tax Returns: A Roadmap for Economic Development Lenders

As the statewide association of economic development professionals, PEDA strives to provide finance-focused training opportunities. Many economic development finance professionals have honed their lending skills while on the job and through various economic development finance training options.

Form 1120. Form 1165. Schedule C. Schedule K. What do all of these mean? This session will aim to alleviate the perplexing task of navigating and understanding federal tax returns. Presenters will provide economic development lenders with key tactics to understand various business structures and correlation to federal tax returns. Session elements include:

- Basics of and differences between common types of business structures
- Legal and tax considerations different business structures
- Tax return basics (Forms and Schedules) for different types of business structures

Keynote Presentation: Coming Up for Air

Small business owner and leadership expert, Nancy Walsh, reflects on the experiences of starting a new business in the midst of a pandemic and coaching individuals and teams through the fear, frenzy and opportunities of 2020. She discusses the importance of connection, the problem-solving magic of appreciative inquiry, and the “twin super-powers of leadership” (self-awareness and empathy). As she does in all her talks, Nancy invites participants to share their questions and perspectives throughout the session.

Transformation of a Region: Urban & Suburban Philadelphia in the 21st Century

From the changing city skyline and the reimagining of the iconic Navy Yard to the growth of 21st century economic sectors and a boom in suburban development along with the evolution of the region’s educational institutions, Greater Philadelphia has experienced a multitude of changes over the past two decades. Not resting on its laurels, the region is poised for exciting new development and to be the world leader in emerging sciences as well as one of the most attractive places to live and invest in the nation. This session explores how the region got here and what’s next for the city and four counties that make up nearly two-fifths of the Commonwealth’s economic output.

Demystifying RACP - 101

Many industry professionals are aware of the Redevelopment Assistance Capital Program (RACP), the Commonwealth grant program administered by the Office of the Budget for the acquisition and construction of, among others, economic development projects. With RACP representing an important tool that can be paired with PIDA and other funding sources to bring job-creating projects to fruition, PEDA believes economic development professionals across the state should be familiar with this program. Recognizing that not every organization’s economic development staff has the same level of experience with the program, PEDA has developed this session’s content to include an introduction to the basics of the program (i.e., summary, eligible uses of funds, key players, etc.), an overview of the application process (i.e., Capital Budget Itemization Act, eRACP, award, application and business plan, etc.) and compliance requirements and time for Q&A.

How to Track, Amplify & Operationalize Your Talent Attraction Efforts

Talent attraction has become a major focus for EDOs across the country, with cities and regions investing in marketing and placemaking initiatives to recruit and retain new residents. In the wake of the COVID-19 pandemic and migration out of major cities, smaller cities and rural regions have an unprecedented opportunity to attract residents with their affordability, outdoor recreation, and quality of life. But once you've grabbed the attention of a potential new resident, how do you connect with them and create a "path to yes" for their relocation to your community? What role can local employers play in this process? And how do you prove your marketing efforts are resulting in new residents?

Most talent attraction programs stop after a catchy slogan, ad campaign, or talent-focused website. These are all important pieces of the puzzle, but RoleCall's innovative approach to talent attraction focuses on the "what's next" — targeting, engaging, and nurturing the talent you need, and converting them to new residents.

Whether you have a robust talent attraction program or are in the very early stages of addressing your community's talent needs, this session will provide you with actionable next steps for tracking, engaging and nurturing potential new residents. We'll share simple ways to operationalize the talent attraction process, how to set up a centralized talent attraction infrastructure, best practices for engaging with potential new residents, and meaningful ways to get local employers and ambassadors involved.

C-PACE offers building owners low-cost, long-term financing for energy efficiency, renewable energy, and water conservation projects. These projects can create jobs, spur business growth, and increase property values. They also make buildings more resilient, create significant energy savings, and show a community's commitment to the environment.

C-PACE is growing rapidly in Pennsylvania and CEODs should have this valuable tool in their economic development toolbox. Learn how to partner with municipalities, property owners, and developers to maximize the economic and environmental benefits of this innovative financing tool.

The Role of EDOs in Fostering Diversity, Equity & Inclusiveness

Being an active participant to bring about change in your community – how an economic development organization can work to create a more diverse, equitable and inclusive culture:

- Is your board reflective and representative of your community? Do you provide a platform for all community members? Does everyone have an opportunity to have a seat at the table?
- Do your MBE/person-of-color-owned businesses have access to fair and equitable working capital and contracts? Do you provide educational support and technical assistance around social entrepreneurship? Do you provide opportunities for networking or peer-to-peer support?
- Do you provide education, technical assistance, or funding to start-ups and/or support at other businesses' life stages?
- Are your neighborhoods equitable for all?
- Do you partner with other organizations to expand any of these services?

This session will offer suggestions to create a more lasting and meaningful impact in your community. Hear from leaders from various communities and organizations on how they are bringing about more equitable change in their own community.

The Role of Improvement Districts in Economic Development

Throughout the world, business improvement districts (BIDs), and related placemaking organizations, work each day to provide their stakeholders with coordinated strategies designed to drive economic development activity in their respective communities.
